1. OHAA-Qld joins History Queensland

We are pleased to announce that we have joined History Queensland thus joining a large network of Queensland historical societies and museums. History Queensland Inc was established as a not-for-profit organisation in the state of Queensland in 1995. The Association was formed as a state-wide umbrella organization to encourage liaison and cooperation between local and family history societies, to promote greater awareness of local and family history and to encourage all levels of government to recognize the importance of local and family history. The Association publishes a quarterly newsletter, History Queensland News as a means of communication and of disseminating information relevant to the interests of member societies. 2. Macquarie University PhD Scholarship

A full-time Macquarie University Research Excellence PhD scholarship in oral history (MQRES) is available in the Department of Modern History, Politics and International Relations to work with Associate Professor Robert Reynolds and Dr Shirleene Robinson.

This scholarship is part of a funded ARC Linkage project LP120200315, which uses oral history to explore the past and present lived experiences of lesbian and gay Australians. Please quote the allocation reference number 2013096 on your application form. Project Name: The Past in the Present: Australian Lesbian and Gay Life Stories.

There is scope for the successful PhD candidate to study any aspect of gay and lesbian history in Australia's past or a topic that investigates oral history as a methodology. Associated topics might include memory and subjectivity as expressed in oral history. Applicants should have completed an Australian four-year undergraduate degree in a relevant discipline (Modern History, Politics) with first class honours, or be able to demonstrate equivalent research qualifications. The tenure is 3.5 years full-time subject to satisfactory progress. The 2013 MQRES full-time stipend rate is \$24,653 pa tax exempt for 3.5 years.

3. Maritime History Prizes

Writers, publishers and readers of maritime history are invited to nominate works for biennial maritime history prizes totalling \$4,000, sponsored by the Australian Association for Maritime History (AAMH) and the Australian National Maritime Museum (ANMM). The Australian Community Maritime History Prize of \$500 will be awarded to a regional or local museum or historical society for a publication (book, booklet, educational resource kit, CD, DVD or other media) relating to an aspect of maritime history of that region or community, and published between 1 January 2011 and 31 December 2012.

The 2013 Frank Broeze Memorial Maritime History Prize of \$3,500 will be awarded for a book treating any aspect of maritime history relating to or impacting on Australia, written or co-authored by an Australian citizen or permanent resident, and published between 1 January 2011 and 31 December 2012.

Both prizes reflect the wishes of the two sponsoring organisations to promote a broad view of maritime history that demonstrates how the sea and maritime influences have been more central to the shaping of Australia, its people and its culture than has commonly been believed. 4. Brisbane City Council Grants and Awards

Brisbane City Council's Community History Grants provide funding to local non-profit community groups for projects to:

- Increase the community's access to, and appreciation of Brisbane's history and heritage
- Support projects that raise the profile and accessibility of Brisbane's history and heritage. Funding is available from \$2,000 to \$10,000.

Lord Mayor's Helen Taylor Award for Local History. The Lord Mayor's Helen Taylor Award for Local History honours the work of the late historian, Helen Taylor. Eligible projects include those that:

- * Reveal lesser known aspects of Brisbane's history or heritage
- * Make Brisbane's history or heritage accessible to a wide audience
- * Focus on local Indigenous history or heritage
- * Encourage excellence in research

One award of up to \$10,000 is given annually to a history student or independent researcher whose work focuses on Brisbane's history, or a particular aspect of it. 12. Objects of Love and Longing

Dr Anne Monsour, President of the Australian Lebanese Historical Society has begun a very interesting project which she describes here:

In our everyday lives we are surrounded by material objects that hold the memories and stories of our lived experiences. The Australian Lebanese Historical Society is developing a new project which aims to record these individual memories and stories and use them to tell the collective story of Lebanese immigrants and their descendants. We are asking immigrants and their descendants to choose a particular object that is special to them. The object could be something brought from Lebanon

by their grandparents, parents or themselves, or something of special significance for the family including: pieces of handicraft, cooking implements, coffee pots, plants such as grapevines, fig, pomegranate or olive trees, a carpet, a photograph, a letter, a naturalization certificate.

15. Our Gentle Defence

One of our members, Lena Volkova, is embarking on a very interesting project interviewing Australian female war veterans of recent conflicts. She has already done some work with male veterans. Here is an excerpt from the story of her project:

I was always fascinated by the ability of oral history to heal old wounds by a mere act of telling. This therapeutic capacity of oral history is very well known and explored by the researchers and practitioners in the helping professions around the globe. Whether it is just a short story of an event told in a confessional manner in order to get it off your chest or an attempt to carefully unpack memories in a life story series, oral history usually brings about healing. The last two decades have seen the rapid development of various types of storytelling; many of them are based on oral history interviews. As we know from other publications, including the ones on our OHAA-Qld site, these types of storytelling embrace almost all genres – theatre, dance, circus (yes, I am talking about the global phenomena of the Cirque de Soleil), visual arts, creative writing, digital arts, films. I was looking for a possibility to design a project where creative expression meets healing and I wanted to use the storytelling platform to let the synergy happen.

A new PhD scholarship is being offered as part of the Trailblazing Women and the Law project funded by the Australian Research Council for three years (2012-2015).
