Jill Adams, National President says - As our AGM has been scheduled for 22 September 2013, during the Biennial conference in Adelaide, I have attached the Notice of Meeting and will circulate my reports as both President and Treasurer in due course. I would like to draw your attention to Item 5 of the AGM agenda as it relates to the change of our name and constitution. The national committee has been working towards changing the constitution for some time now and has received very positive comments about the drafts that have been circulated, in particular the final draft, which I have attached, and the proposal for a new name for our association. There are no significant changes from the earlier draft forwarded to you in May, but this version includes comments and suggestions received from individual members and the state oral history associations. I have outlined what the main changes are and the effect that they will have on state branches.

Jack Dougherty and Candace Simpson have shared an essay titled, "Who owns oral history? A Creative Commons solution," which is freely available online at:

Jack says - the essay describes how we have moved away from our 1990s consent form (where we required participants to sign over their copyright) to our newer Creative Commons form (where the participant retains the copyright, but agrees to allow us to freely share the interview on the public web, for non-commercial use). Sample consent form language is included. We welcome feedback from oral historians by posting a comment at the bottom of the essay webpage.
